A meeting of the **Board of Trustees of the Pend Oreille Hospital District** was held in the classroom at Bonner General Hospital.

The meeting was called to order at 7:00 a.m. by Tom Lawrence, Chairman.

Business:

- 1. Approval of Agenda: Motion to approve Agenda was made by Scott Burgstahler, seconded by Bart Casey. The Agenda was approved as is by unanimous vote.
- 2. Tom Lawrence gave a report of the May 21, 2019 Election Results to the Board Members. Motion to accept the Scott Burgstahler as Trustee for a 6 year term was made by Shawn Woodard, seconded by Bart Casey and approved by unanimous vote. Certificate of Election to the office of Trustee of the Pend Oreille Hospital District for a term of 6 years, was handed out to Scott Burgstahler.
- 3. Bart Casey made the motion to approve the minutes of the April 23, 2019 meeting. The motion was seconded by Scott Burgstahler. The Minutes were approved by unanimous vote.
- 4. Motion was made by Shawn Woodward to acknowledge receipt of the checks, motion was seconded by Scott Burgstahler. Approved by unanimous vote.
- 5. John Hennessy reviewed the First Quarter Finances for the POHD Clinics. Handouts were given to each member present. Funding Requests for POHD Clinics are as follows:

Shawn Woodward made the motion that any comments received be included in the POHD Meeting packet. If any of the members feel the comment needs further discussion, they can let the Chairman know and it will be added to the Agenda. Bart Casey seconded the motion. Approved by unanimous vote.

- 9. Scott Burgstahler made the motion to adjourn, seconded by Shawn Woodard and was approved by unanimous vote. The meeting was adjourned at 7:10 a.m.
