A meeting of the Board of Trustees of the Pend Oreille Hospital District was held in the HSB Monarch/Cabinet Room.

Present: Tom Lawrence, Dwayne Sheffler, Tim Cochran, and Jim Frank. Helen Parsons attended by phone. Others present: Erin Binnall, Stacey Good, DO, and Sharon Beeman, Secretary. Public Attendance: One person from the public attended the meeting by phone.

The meeting was called to order at 7:00 a.m. by Tom Lawrence.

Business:

- Agenda Motion to approve the agenda was made by Dwayne Sheffler, seconded by Tim Cochran. Agenda was approved by 5 yea votes.
- 2. Approval of Minutes from May 23, 2023. Motion to approve the minutes was made by Jim Frank, seconded by Tim Cochran. Approved by 5 yea votes.
- 3. Treasurer's Report. The May Treasurer's Report was reviewed by Jim Frank. One County Warrant was received this month, dated 6/8/23 for \$55,925.75. Tim Cochran made the motion to approve receipt of the County Warrant and accept the Treasurer's Report, Dwayne Sheffler seconded. Motion was approved by 5 year votes.

 went up at a 4.48% increase from last year. Jim Frank made motion to approve increase and sign new sublease,
 seconded by Dwayne Sheffler. Approved by 5 yea votes.
- 6. Erin Binnall gave a report on the goals set for Sandpoint Women's Health and Behavioral Health. A handout was given to each of the Trustees. Dr. Good addressed looking at space issues and services for the future. Question and answer was held.
- 7. Planning & Zoning Notices We have been keeping the notices that come to the POHD in a binder for the last year and it has been determined that there is no useful purpose in continuing to do. Bart Casey made the motion to stop keeping these notices, seconded by Jim Frank Approved by 5 year votes.
- 8. Public Comment. The person from the public had no comments.
- 9. Next meeting is July 25, 2023. The meeting will be in the HSB Monarch/Cabinet Room at 7 a.m.
